Admission Fee: \$5.00

◇Maui Historical Society Members will be admitted free.

◇Those purchasing a year's membership to Maui Historical Society will also be admitted free.

Evaluation fee: \$10.00 per object

A maximum of two objects per exhibitor may be selected for evaluation. Bailey House staff and trustees retain sole discretion on selecting objects for evaluation and/or featured exhibition. Exhibitors shall be responsible for delivery, transport, and safe handling of registered objects to and from Bailey House Museum. Bailey House Museum and its staff shall not be responsible for storage, maintenance, or repair of any objects brought to event.

Registered objects should be artifacts, antiques, sculptures, curios or artwork pertinent to Hawaii and the Pacific/Asian basin and be of historical or cultural relevance.

Potential exhibitors must complete this agreement and submit it to the Maui Historical Society, 2375-A Main Street, Wailuku, HI 96793, on or before July 15, 2009. Exhibitors will be notified on or before Friday, July 31<sup>st</sup>, 2009 as to whether object has been accepted for evaluation. Fees shall be due and payable on day of event.

LIABILITY: The Maui Historical Society, Bailey House Museum, its employees, trustees, sponsors, agents, and volunteers shall not be responsible for any injury, loss, or damage from any cause whatsoever, that may be suffered by an exhibitor, exhibitor's employees, or representatives, or to exhibitor's objects, artifacts, antiques, sculptures, curios, or artwork, while on the grounds of the Bailey House Museum and/or participating in the event. The exhibitor, upon execution of this agreement, expressly releases the Maui Historical Society, the Bailey House Museum, and all individuals, volunteers, trustees, and employees thereof, from any and all claims for any such loss, damage or injury arising from attendance or participation in the event. The Maui Historical Society makes no warranty as to the accuracy of any historical interpretations and evaluations made by participating evaluators, staff, agents, volunteers or representatives. Any and all restrictions or levies regarding the possession of antiques, cultural artifacts and relics, imposed by the laws of the United States, the State of Hawaii, and the Maui Historical Society must be observed. The possession, presentation or display of looted Hawaiian burial artifacts is expressly forbidden at this event.
